RESOLUTION OF THE CITY COUNCIL, CITY OF SAN
DIEGO, PRESENTED TO THE UNITED STATES AIR
FORCE ACADEMY AWARENESS TEAM.

WHEREAS, the U.S. Air Force Academy (USAFA), the San Diego Unified School District (SDUSD) the Urban League of San Diego, the S.D. Air Force Association, and the USAFA Parents Association of San Diego and Liaison Officers have joined forces to motivate minority and/or needy students in the San Diego area to do well in school and eventually pursue a college education; and


WHEREAS, the schools of Keiller Middle School and Morse High School actively participate in this program where students are encouraged to challenge themselves in leadership and physical skills; and
