BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$100,000 from Water Revenue Fund No. 41502, Unallocated Reserve (70679), to Water Operating Fund No. 41500, Water Operations Engineering Program (70830), and an amount not to exceed \$100,000 within Sewer Revenue Fund No. 41506 from the Unallocated Reserve (70679) to the Sewer Operations Engineering Program (70820).

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$200,000.00 consisting of \$100,000.00 from Water Operating Fund No. 41502, Water Operations Engineering Program (70830), and \$100,000.00 from Sewer Revenue Fund No. 41506, Sewer Operations Engineering Program (70820), is hereby authorized,

solely and exclusively for the purpose of providing funds for the above project.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this agreement with tax-exempt securities if circumstances warrant.
