BE IT RESOLVED, by the Council of The City of San Diego that the contract of PACIFIC SAFETY EQUIPMENT CO. is hereby rescinded for furnishing LATEX EXAM GLOVES, Item 1, for a period of one (1) year beginning January 15, 1990 through January 14, 1991.

BE IT FURTHER RESOLVED, that the second low acceptable bid of BIOSAFETY SYSTEMS, meeting specifications, is hereby accepted for the balance of the contract period and the City Manager is hereby authorized to execute a contract for LATEX EXAM GLOVES, Item 1, at a total annual estimated cost of \$44,240.63 including tax with an option to renew the contract for one (1) additional one (1) year period with price escalation not to exceed 10% of prices bid.

BE IT FURTHER RESOLVED, that the low acceptable bid of BIOSAFETY SYSTEMS, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of LATEX EXAM GLOVES, Items 2, 3 and 4, per prices on file in the Purchasing Department; terms 2% 10 days, with an option to renew the contract for an additional one (1) year period with a price escalation not to exceed 10% of prices bid.
