BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT COLUSA STREET AND FRIARS ROAD, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on JUN 11 1990, and bearing official Document No. U.O. 119550, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT COLUSA STREET AND FRIARS ROAD.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$107,500 from Fund 79503, CIP No. 62-292.0, TRAFFIC SIGNALS - DIF FUNDED is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to retain excess budgeted funds, if any, in CIP No. 62-292.0.
