f. Replacef of facilities
The maintenance shall be for a period of one year, terminating on June 30, 1991.

The expenses of the contemplated maintenance hereinbefore mentioned are made chargeable upon the district hereinafter described and the Council does declare said district to be the district benefitted by the maintenance and to be assessed to pay the costs and expenses thereof.
