WHEREAS, the City Council has previously approved and the City Manager has executed Agreements with the San Diego Housing Commission for use of Eighth (1982), Ninth (1983), Tenth (1984), Twelfth (1986), and Fourteenth Year (1988) Community Development Block Grant (CDBG) funds; and

WHEREAS, a total of \$1,314,670 of CDBG funds has been allocated but is not now contractually obligated to the Housing Commission; and

WHEREAS, the Tenth, Twelfth and Fourteenth Year Agreements do not include the category of acquisition; and

WHEREAS, the Housing Commission now wishes to use a total of \$3,005,417 of unexpended Eighth, Ninth, Tenth, Twelfth and Fourteenth Year CDBG funds towards the acquisition of four sites and thirteen existing developments for public housing; and

WHEREAS, Findings of No Significant Impact (FONSI)/Negative Declarations (Neg. Decs.) have been prepared, but have not been certified for the four sites proposed for acquisition; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the City Manager is hereby authorized to amend the City's CDBG Agreements with the San Diego Housing Commission, so as to:
 - * Include the category of low income housing and housing site acquisition in the Tenth, Twelfth and Fourteenth Year Agreements;
 - * Incorporate an additional \$1,314,670 of previously allocated funds in the Twelfth Year Agreement; and
 - * Reallocate Eighth, Ninth, Tenth, Twelfth and Fourteenth
 Year CDBG funds from the uses for which they are now
 designated to low income housing and housing site
 acquisition, in the following manner:
