
ADOPTED ON JUN 11 1990

City of San Diego, resulting from the improvement agreement between the City of San Diego and Alta Del Mar, entered into in November, 1986.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$70,000.00, made payable to Alta Del Mar and its attorney of record Donald R. Worley in full settlement of the lawsuit and of all claims.
