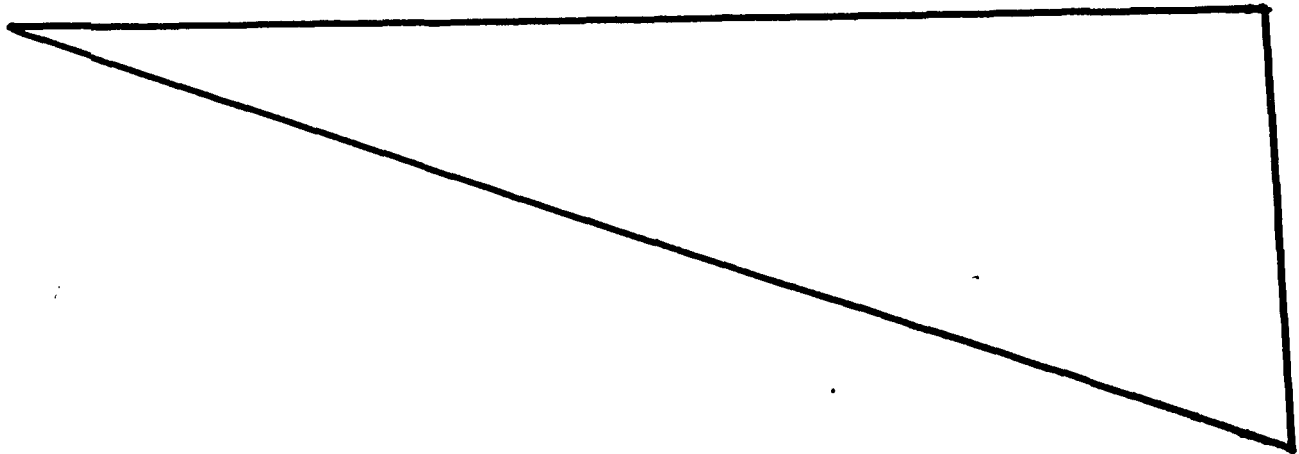

WHEREAS, the petition was properly filed and found to contain sufficient verified signatures of over ten percent (10%) of the City's registered voters as required by the Charter for submission to the voters; and

WHEREAS, the Council under Municipal Code section 27.2521 must approve or reject the legislative act as presented by the above-referenced petition; and

WHEREAS, the Council under Municipal Code section 27.2522 must call a special election to be consolidated with the next City-wide election should the Council reject the above-referenced petition; NOW, THEREFORE,
