A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE PUBLIC STREETS, HIGHWAYS, AND SERVICE EASEMENTS VACATION LAW, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE CALIFORNIA STREET BETWEEN "F" STREET AND "G" STREET AND ADJACENT TO BLOCK 35 AND BLOCK 36 OF NEW SAN DIEGO MAP 456, AND FIXING A TIME AND PLACE FOR THE PUBLIC HEARING THEREOF.

- 3. The Council hereby elects to proceed, in making said vacation, under the provisions of the "Public Streets, Highways, and Service Easements Vacation Law."
- 4. The Council hereby fixes 10:00 a.m. on the 24th day of July _____, 1990 in the Council Chambers on the twelfth floor of the City Administration Building, Charles C. Dail Concourse, 202 "C" Street, in said City of, San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.
