RESOLUTION NUMBER R- 275913

ADOPTED ON JUN 18 1990

WHEREAS, The City of San Diego recognizes the need for quality, affordable, accessible child care for its employees; and

WHEREAS, the City Council implemented a Child Day Care Policy (Council Policy 300-12) in September, 1985 that states, "It shall be the policy of the City Council to ensure that quality child day care services are provided to City employees at the earliest practicable date; to cooperate with agencies, organizations, and individuals in the public and private sectors who are endeavoring to meet the need for child care services in the City of San Diego; and to support the efforts of State legislators to facilitate the provision of affordable child care services to the citizens of California;" and

WHEREAS, Kinder-Care, Children's World, and La Petite Academy are the three largest private providers of child care programs in the nation, with a total of over 30 child care centers in San Diego County; and

WHEREAS, Kinder-Care, Children's World, and La Petite Academy have each agreed to offer a 10% child care discount to City employees; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, three separate agreements with KINDER-CARE, CHILDREN'S WORLD, and LA PETITE

ACADEMY, INC., for child care services for City employees, under the terms and conditions set forth in the Agreements on file in the office of the City Clerk as Document Nos. RR- 275913 -1, RR- 275913 -2, and RR- 275913 -3, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that The City of San Diego is appreciative of the discount being offered, and commends Kinder-Care, Children's World, and La Petite Academy for their generosity.

BE IT FURTHER RESOLVED, that The City of San Diego will not endorse these child care programs, but will leave the responsibility of choosing the type of child care most appropriate for their children to the decision of the parent.
