
ADOPTED ON JUN 18 1990

HUBBARD, for the continued operation of the Fire Department's Temporary Fire Station 24 at the yearly rate of \$18,000, under the terms and conditions set forth in the Lease Agreement on file in the office of the City Clerk as Document No. RR-275915.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$18,000 from the General Fund for lease cost from July 1, 1990 to June 30, 1991, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
