
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Camp Dresser & McKee for environmental/geotechnical consulting services at the North Chollas landfill, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 275922 , together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost which the City Manager shall deem necessary from time to time to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$260,000.00 from the Refuse Disposal Enterprise Fund 41200, CIP No. 37-219, North Chollas Soil Contamination Project, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer excess budgeted funds, if any, to the appropriate reserves on advice of the administering department.
