WHEREAS, Billie Milam is a recognized expert in the field of sculpture conservation-restoration; and

WHEREAS, the Davidson Communities has donated \$14,000.00 for the necessary conservation-restoration of the statuary on the condition that the services be performed by Billie Milam; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that for and on behalf of the City, the Council accepts the generous gift of \$14,000.00 from the Davidson Communities for restoration of the statuary in Balboa Park.



BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered, for and on behalf of the City, to engage the services of Billie Milam, Sculpture Conservator, to perform the requisite conservation-restoration work, at a cost not to exceed \$14,000.00 as a condition of the City's acceptance of the Davidson Communities' gift.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to expend the donation of \$14,000.00 upon its receipt by him and his issuance of an Auditor's Certificate.
