BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$329,057.30 from Assessment District Fund 79364; \$23,655.43 from Landscape Maintenance District Fund 70240 and \$81,831.48 available from Sewer Revenue Fund 41506, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
