RESOLUTION ADOPTING A MAP CLASSIFYING
SINGLE-FAMILY NEIGHBORHOODS IN THE GREATER GOLDEN
HILL COMMUNITY AND RELEASING THE COMMUNITY FROM
THE SINGLE-FAMILY NEIGHBORHOOD PROTECTION
ORDINANCE (O-17250 (NEW SERIES)).

WHEREAS, The City of San Diego has adopted the Single-Family
Neighborhood Protection Ordinance (O-17250 (New Series)) and
initiated a program to identify all areas to be classified as
protected single-family neighborhoods; and

WHEREAS, on September 21, 1989, and November 2, 1989, the
Planning Commission of The City of San Diego held public hearings
to consider adoption of a map classifying protected single-family
neighborhoods in the Greater Golden Hill Community Planning Area
and release of the remainder of the community from the
Single-Family Neighborhood Protection Ordinance (O-17250 (New
Series)); and

WHEREAS, the Planning Commission approved the Greater Golden
Hill single-family protection map and recommended release of
those areas of the community not mapped for classification as
protected single-family neighborhoods from the Single-Family
Neighborhood Protection Ordinance; and

WHEREAS, the proposed actions would fulfill the goals of the
Greater Golden Hill Community Plan, the Progress Guide and
General Plan and the Single-Family Neighborhood Protection
Ordinance (O-17250 (New Series)); and

WHEREAS, the Council of The City of San Diego has considered all maps, exhibits and written documents contained in the file for this project on record in The City of San Diego, and has considered the oral presentation given at the public hearing; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby approves the protected single-family neighborhood map in the Greater Golden Hill Community Planning Area.

BE IT FURTHER RESOLVED, that the Council of The City of San Diego hereby releases from the provisions of the Single-Family Neighborhood Protection Ordinance (O-17250 (New Series)) those areas not mapped for classification as protected single-family neighborhoods in the Greater Golden Hill Planning Area.
