BE IT RESOLVED, by the Council of The City of San Diego that the low bid of ONE TRIPP TREE SERVICE, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for TREE MAINTENANCE SERVICE IN THE SCRIPPS-MIRAMAR OPEN SPACE DISTRICT as may be required for a period of one (1) year beginning July 1, 1990 through June 30, 1991, at a cost of \$55.00 per crew hour, for a total estimated cost of \$38,500; terms net 30 days, with options to renew the contract for four (4) additional one (1) year periods with escalation not to exceed 5% of prices in effect at the end of each prior year.

BE IT FURTHER RESOLVED that in the event the Contractor does not perform to specifications, the Purchasing Agent is hereby authorized to terminate the contract and award to the next low responsive and responsible bidder and to subsequent bidders, if necessary, until a bidder is found who performs to specifications.
