BE IT RESOLVED, by the Council of The City of San Diego that the low bid of HAZ-STOR COMPANY, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of THREE (3) HAZARDOUS MATERIALS STORAGE BUILDINGS as follows: one (1) each sixteen (16) ft. building at a cost of \$24,138.00, one (1) each twenty (20) ft. building at a cost of \$18,463.00, and one (1) each eight (8) ft. building at a cost of \$9,573.00, and an estimated 400 linear feet of steel shelving at a cost of \$24.00 per foot, for a total combined cost of \$61,774.00; terms net 30 days, plus sales tax.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$66,252.62 (\$33,126.31 from Department No. 443, Organization No. 620, Object Account No. 6010, and Job Order No. 044362, and \$33,126.31 from Department No. 443, Organization No. 520, Object Account No. 6010, and Job Order No. 044352) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
