

RESOLUTION NUMBER R- 275955

ADOPTED ON JUN 25 1990

BE IT RESOLVED, by the Council of The City of San Diego that the low acceptable bids of CHINO-CORONA FARMS, INC. and BURNS AND SONS TRUCKING, INC., meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for REMOVAL AND DISPOSAL OF AN ESTIMATED 120,000 TONS OF DIGESTED SLUDGE from Fiesta Island as may be required for a period of one (1) year beginning August 1, 1990 through July 31, 1991 as follows:

1. CHINO-CORONA FARMS for approximately 80,000 tons of sludge at a cost of \$20.78 per ton, for a total estimated cost of \$1,662,400; terms .05% ten (10) days, net 30 days; with options to renew for two (2) additional one (1) year periods, with a price escalation not to exceed 10% of prices in effect at the end of each prior year.
2. BURNS AND SONS TRUCKING, INC. for approximately 40,000 tons of sludge at a cost of \$21.92 per ton, for a total estimated cost of \$876,800; terms 1% 10 days, net 30 days; with options to renew for two (2) additional one (1) year periods with a price escalation not to exceed 10% of prices in effect at the end of each prior year.

BE IT FURTHER RESOLVED that in the event that a successful bidder does not perform in accordance with specifications, the Purchasing Agent is hereby authorized to terminate the contract and to re-award to the next low responsible and responsive bidder and to subsequent bidders, if necessary, until a bidder is found who can comply with specifications.
