
RESOLUTION NUMBER R- 275956

BE IT RESOLVED, by the Council of The City of San Diego that the low bid of REHRIG PACIFIC COMPANY, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of 30,000 SETS OF STACKABLE PLASTIC CONTAINERS FOR THE CURBSIDE RECYCLING PROGRAM at a cost of \$10.41 each for a total cost of \$312,300.00 plus freight charge of \$4,800.00; terms 1% 10 days, plus sales tax.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$339,741.25 from Fund No. 41200, Department No. 751, Object Account No. 3217, and Job Order No. 007421, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
