
WHEREAS, pursuant to the Landscape and Lighting Act of 1972

WHEREAS, the Council of The City of San Diego, on August 10, 1987, by Ordinance No. O-18924 (New Series), created the Gateway Center East Business Improvement District pursuant to the Parking and Business Improvement Law of 1979 (California Streets and Highways Code section 36500 et seq.); and

WHEREAS, the Board of Directors of the Southeast Economic Development Corporation has requested to terminate their Agreement to administer funding for the district; and

WHEREAS, no other agency has been identified to administer the funds received from assessments in the district; NOW, THEREFORE, BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. Notice is hereby given that July 24, 1990 at the hour of 10:00 a.m. in the Council Chambers of the City Administration Building, 202 C Street, San Diego, California, is fixed as the time and place when and where any and all interested persons having a desire to be heard may appear and state their views for or against the distestablishment of the district.

Section 2. Gateway Center East Business Improvement District be distestablished and that any fund balance be distributed according to Parking and Business Improvement Law of 1989 (California Streets and Highways Code section 36500 et seq.).

Section 3. The City Clerk is hereby directed to to give notice of the aforementioned hearing by publication pursuant to Section 36550(b) of the California Streets and Highways Code
