AMOUNT: \$160
SUGGESTION: Mr. Schulte was a Fire Fighter at the time of this suggestion. He suggested that the First Responders use a double-tube type of stethoscope instead of the single tube currently used. This will be more effective in field conditions.

NAME(S): Richard J. Hunt
DEPARTMENT: Engineering & Development
AMOUNT: \$67.50
SUGGESTION: Mr. Hunt was an Assistant Civil Engineer when he suggested purchasing Xerox copies of the County Assessor's Tax Maps rather than the more expensive blueline copies. This resulted in a savings of \$675.00.
