
ADOPTED ON JUN 25 1990

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$21,981.20 for additional lease costs for FY 1990/1991 from Fund 60011, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
