WHEREAS, City, acting through the City Council, has since 1980 approved the San Diego Police Department's Psychological Services Program; and

WHEREAS, the two major components of the Psychological Services Program are Component I: Psychological Screening of Police Applicants, and Component II: Psychological Counseling and Training for Police Department Employees; and

WHEREAS, contractors are ready, willing, and able to provide needed professional services under the general supervision of the Chief of Police, or his designated representative for the Component II: Psychological Counseling and Training of Police Department Employees; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the firms of Focus Psychological Services and Vista Hill Community Treatment Systems, contractors, for continuation of psychological counseling and training portion of the Police Department's Psychological Services Program from July 1, 1990, through June 30, 1993, under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 276011.

BE IT FURTHER RESOLVED, that the expenditure of an amount estimated to be \$178,875 from Fund No. 100, Department 110, Organization No. 320, Account No. 4151, Job Order No. 111215, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
