ADOPTED ON JUNE 26, 1990

WHEREAS, the U.S. Department of Veterans Affairs estimates that over 30% of homeless Americans are veterans; and

WHEREAS, these men and women have provided proud and vital services to America and our community, both in peace and during war; and

WHEREAS, the Vietnam Veterans of San Diego, in conjunction with the City and County of San Diego, local veterans organizations, activity duty military commands, local, state and federal agencies, and over fifty public and private organizations, will be sponsoring "Stand Down '90" the week of July 2, 1990 through July 6, 1990; and

WHEREAS, "Stand Down" is a nationally recognized effort to assist homeless veterans with a wide range of assistance including food, clothing, employment, medical and mental health services, legal assistance, and substance abuse treatment; and

WHEREAS, during "Stand Down '90," a special joint hearing by the California State Senate and Assembly Committees on Veterans Affairs will be held on the "Stand Down" site to discuss the issue of Homeless Veterans in our state; and

WHEREAS, over twenty representatives from all parts of our nation will be attending "Stand Down" to participate and receive technical assistance to replicate the "Stand Down" concept in their own communities; NOW, THEREFORE,
