

RESOLUTION NUMBER R- 276017

ADOPTED ON JUN 26 1990

ADOPTING THE NORTHEASTERN AREA, COMMONLY KNOWN AS NORMAL HEIGHTS, IN THE GREATER NORTH PARK COMMUNITY PLANNING AREA AS PROTECTED SINGLE-FAMILY NEIGHBORHOOD AND RELEASE THE SAME COMMUNITY FROM ORDINANCE NO. O-17250 (NEW SERIES).

WHEREAS, The City of San Diego has adopted the Single-Family Protection Ordinance (O-17250 (New Series)) and initiated a program to identify all areas to be classified as protected single-family neighborhoods; and

WHEREAS, on June 7, 1990, the Planing Commission of the City of San Diego held a public hearing to consider a map classifying protected single-family neighborhoods in the northeastern portion of the Greater North Park Community Planning Area; and

WHEREAS, the Planning Commission recommended denial of the redesignation from multi-family to single-family of the northeastern area of the Greater North Park Community Planning Area; and

WHEREAS, the Planning Commission recommends maintaining the existing multi-family land use designations and implementing zones; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That this Council hereby approves the proposed Greater North Park Community Plan amendment, a copy of which is on file in the office of the City Clerk as Document No. RR- 276017.


