

RESOLUTION NUMBER R- 276019

ADOPTED ON JUN 26 1990

WHEREAS, the Public Facilities and Recreation Committee of The City of San Diego held a public hearing on June 13, 1990, to consider the proposed Memorandum of Understanding between The City of San Diego (City) and the San Diego Arena Corporation (SDAC), for the construction of a new sports arena facility in the Sorrento Hills Community; and

WHEREAS, the Public Facilities and Recreation Committee approved and recommended adoption by the City Council of the said Memorandum of Understanding, subject to the modifications identified at the Public Facilities and Recreation Committee hearing; and

WHEREAS, the Council of The City of San Diego held a public hearing to consider the said Memorandum of Understanding and, by a majority vote, approved said Memorandum of Understanding; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby approves the Memorandum of Understanding between City and SDAC, a copy of which is on file in the office of the City Clerk as Document No. RR- 276019, and hereby authorizes the City Manager to execute the Memorandum of Understanding on behalf of the City, with clarification language for paragraph 5 acceptable to the City Attorney, which language will make it clear that by entering into the Memorandum of


