APPROVING A PORTION OF AREA 9 TO BE CLASSIFIED AS A PROTECTED SINGLE-FAMILY NEIGHBORHOOD IN THE MID-CITY COMMUNITY PLANNING AREA AND RELEASE OF THE SAME COMMUNITY FROM ORDINANCE NO. O-17250 (NEW SERIES).

WHEREAS, the City has adopted the Single-Family Protection Ordinance (0-17250 (New Series)) and initiated a program to identify all areas to be classified as protected single-family neighborhoods; and

WHEREAS, on June 7, 1990, the Planning Commission of The City of San Diego held a public hearing to consider a map classifying protected single-family neighborhoods in Area 9 of the Mid-City Community Planning Area until May 1990; and

WHEREAS, the Planning Commission recommended not to redesignate Area 9 from Residential Medium 5 to Residential Low 1 and rezoned from MR-1500B and MR-3000 to R1-5000; and WHEREAS, the proposed community plan amendment and rezone to the MID-CITY COMMUNITY PLAN would redesignate a section of the Normal Heights neighborhood from multi-family to single-family; and

WHEREAS, the proposed community plan amendment would limit development intensity to preserve the single-family character of the existing neighborhood; NOW, THEREFORE

- 3. That the Council releases those areas which are not mapped for classification as protected single-family neighborhoods in the Mid-City Community Planning Area from the provisions of the Single-Family Neighborhood Protection Ordinance (0-17250 (New Series)).
