ADOPTED ON JUN 26 1990

APPROVING AREA 10 OF THE PROTECTED SINGLE-FAMILY NEIGHBORHOOD MAP IN THE MID-CITY COMMUNITY PLANNING AREA AND RELEASE OF THE SAME COMMUNITY FROM ORDINANCE NO. O-17250 (NEW SERIES).

WHEREAS, the City has adopted the Single-Family Protection Ordinance (O-17250 (New Series)) and initiated a program to identify all areas to be classified as protected single-family neighborhoods; and

WHEREAS, on November 16, 1989, the Planning Commission of The City of San Diego held a public hearing to consider a map classifying protected single-family neighborhoods in Area 10 of the Mid-City Community Planning Area; and

WHEREAS, the Planning Commission recommended Area 10 to be redesignated from Residential Low-Medium 2 to Residential Low 1 and rezoned from MR-3000 to R1-5000; and

WHEREAS, the proposed community plan amendment and rezone to the MID-CITY COMMUNITY PLAN would redesignate a section of the Kensington neighborhood from multi-family to single-family; and

WHEREAS, the proposed community plan amendment would limit development intensity to preserve the single-family character of the existing neighborhood; NOW, THEREFORE



2. That the Council hereby approves the map classifying protected single-family neighborhoods in Area 10 of the Single-Family Neighborhood Protection Map, the amendment to the Mid-City Community Plan and the implementing rezone for the plan amendment.

3. That the Council releases those areas which are not mapped for classification as protected single-family neighborhoods in the Mid-City Community Planning Area from the provisions of the Single-Family Neighborhood Protection Ordinance (O-17250 (New Series)).
