WHEREAS, the City has adopted the Single-Family Protection Ordinance (0-17250 (New Series)) and initiated a program to identify all areas to be classified as protected single-family neighborhoods; and

WHEREAS, on June 7, 1990, the Planning Commission of The City of San Diego held a public hearing to consider a map classifying protected single-family neighborhoods in Area 11 of the Mid-City Community Planning Area until May 1990; and

WHEREAS, the Planning Commission recommended Area 11 not to be redesignated from Residential Low-Medium 3A+ to Residential Low 1 and not to rezone the area from MR-2500 to R1-5000; and

WHEREAS, the proposed community plan amendment and rezone to the MID-CITY COMMUNITY PLAN would redesignate a section of the Normal Heights neighborhood from multi-family to single-family; and

WHEREAS, the proposed community plan amendment would limit development intensity to preserve the single-family character of the existing neighborhood; NOW, THEREFORE
