

RESOLUTION NUMBER R- 276035

ADOPTED ON JUN 26 1990

APPROVING AREA 16 TO BE REDESIGNATED FROM RESIDENTIAL MEDIUM 5 TO RESIDENTIAL LOW MEDIUM 2 IN THE MID-CITY COMMUNITY PLANNING AREA AND RELEASE THIS AREA FROM ORDINANCE NO. O-17250 (NEW SERIES).

WHEREAS, the City has adopted the Single-Family Protection Ordinance (O-17250 (New Series)) and initiated a program to identify all areas to be classified as protected single-family neighborhoods; and

WHEREAS, on November 16, 1989, the Planning Commission of The City of San Diego held a public hearing to consider a map classifying protected single-family neighborhoods in the Mid-City Community Planning Area; and

WHEREAS, the Planning Commission recommended Area 16 not be redesignated from Residential Medium 5 to Residential Low 1 and not to rezone the area from MR-1500B to R1-5000; and

WHEREAS, the proposed community plan amendment and rezone to the MID-CITY COMMUNITY PLAN would redesignate a section of the Talmadge neighborhood from multi-family to single-family; and

WHEREAS, the proposed community plan amendment would limit development intensity to preserve the single-family character of the existing neighborhood; NOW, THEREFORE

BE IT RESOLVED, by the Council of The City of San Diego, as follows:



1. That this Council hereby approves the MID-CITY COMMUNITY PLAN amendment, a copy of which is on file in the office of the City Clerk as Document No. RR- 276021.

2. That the Council hereby denies the classification of Area 16 as a protected single-family neighborhood, and approves the amendment to the Mid-City Community Plan from Residential Medium 5 to Residential Low Medium 2 and the implementing rezone for the plan amendment.

3. That the Council releases this area which is not mapped for classification as a protected single-family neighborhood in the Mid-City Community Planning Area from the provisions of the Single-Family Neighborhood Protection Ordinance (O-17250 (New Series)).
