WHEREAS, the City has adopted the Single-Family Protection Ordinance (O-17250 (New Series)) and initiated a program to identify all areas to be classified as protected single-family neighborhoods; and

WHEREAS, on November 16, 1989, and December 14, 1989 the Planning Commission of The City of San Diego held public hearing to consider a map classifying protected single-family neighborhoods in the Mid-City Community Planning Area; and

WHEREAS, the Planning Commission recommended Area 17 not be redesignated from Residential Low Medium 2 to Residential Low 1 and not to rezone from MR-3000 and MR-1500 to R1-5000; and

WHEREAS, the proposed community plan amendment and rezone to the MID-CITY COMMUNITY PLAN would redesignate a section of the City Heights neighborhood from multi-family to single-family; and

WHEREAS, the proposed community plan amendment would limit development intensity to preserve the single-family character of the existing neighborhood; NOW, THEREFORE
