RESOLUTION NUMBER R- 276039

ADOPTED ON JUL 2 1990

WHEREAS, on July 9, 1890, two Sisters of the Mercy founded St. Joseph's Dispensary, the community's first hospital in downtown San Diego; and

WHEREAS, in 1904, the Sisters of Mercy established the Mercy College of Nursing, San Diego's first training facility for nurses; and

WHEREAS, in 1924, the facility was relocated to its existing Hillcrest location and was incorporated as "Mercy Hospital;" and

WHEREAS, that same year, Mercy Hospital was honored as being one of the first institutions in the country to receive accreditation by the American College of Surgeons; and

WHEREAS, Mercy has grown to be one of San Diego's largest medical facilities, utilizing the latest in medical technology and serving more than 250,000 patients a year; and

WHEREAS, Mercy Hospital will invite the community to celebrate its 100th Anniversary with a week long series of activities called "Festival 100 Celebrating a Century of Care;"
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby recognize and commend Mercy Hospital for providing 100 years of dedicated service, and quality health care to the San Diego community.

BE IT FURTHER RESOLVED, that July 2 through 9, 1990, be and it is hereby designated as "Mercy Hospital Centennial Week" in San Diego.
