BE IT RESOLVED, by the Council of The City of San Diego that the offer of UNIVERSITY FORD CHRYSLER PLYMOUTH, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of one hundred five (105) POLICE PATROL CARS (1991 Ford LTD Crown Victoria Model "S") at a cost of \$10,944.00 each, for a total cost of \$1,149,120.00; terms net 30 days, plus sales tax.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$1,232,431.20 (\$936,647.72 from Fund No. 100, Department No. 110, Organization No. 200, Object Account No. 6010, and Job Order No. 111475; \$147,891.74 from Fund No. 100, Department No. 110, Organization No. 305, Object Account No. 6010, and Job Order No. 111290; and \$147,891.74 from Fund No. 100, Department No. 110, Organization No. 386, Object Account No. 6010, and Job Order No. 111515) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
