BE IT RESOLVED, by the Council of The City of San Diego that the previous low bid of SAN DIEGO TURF, meeting specifications, is hereby accepted and the City Manager is hereby authorized to modify the contract for MISCELLANEOUS TURF SWEEPING EQUIPMENT, per prices on file in the Purchasing Department, for a total cost of \$72,594.00, terms net 30 days, plus sales tax, as authorized by Resolution No. 275638, adopted on May 5, 1990, to increase encumbrance an additional \$1,915.00, for a total of \$74,509.00, to add one additional sweeper (Item 2) at the same price.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$2,053.84, from Department No. 443, Fund No. 100, Organization No. 520, Object Account No. 6010, and Job Order No. 044352, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
