APPROVING MAP OF ONE HARBOR DRIVE.


BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Phillip G. Roberts, Registered Civil Engineer, HARBOR DRIVE being a subdivision of Lot "L," those portions of Lots "A", "B", "I", "J" and "K" in Block 118, all of Lots "A", "B", "C", "D", "H", "I", "J", "K", "L" and portions of Lots "E", "F" and "G" in Block 119 of Horton's addition, in the City of San Diego, County of San Diego, State of California, according to map thereof made by L.L. Lockling, filed in the office of the County Recorder of San Diego County in Book 13, Page 522 of Deeds; together with all those portions of Second Avenue lying between said Blocks 118 and 119, and a portion of "K" Street lying south of, adjacent and contiguous to the south line of Lot "G" in said Block 119, all as vacated and closed to public use by resolutions of the Council of The City of San Diego," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map is in substantial conformance with the approved tentative map; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, and that said Council has approved said subdivision map.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
