WHEREAS, The City of San Diego is the owner of sewer and drainage easements in Lots 1, 2 and 3 of MBM West, Map 12358; and

WHEREAS, the Engineering & Development Department has requested that the City quitclaim to MBM WEST I, a California general partnership, its interest in and to said easements; and

WHEREAS, the owner of the property wishes to clear title to his property; and

WHEREAS, the herein-described property is surplus to City needs; and

WHEREAS, the sale of the aforementioned property is consistent with the public interest: NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- That that certain real property right described in that quitclaim deed on file in the office of the City Clerk as Document No. RR- 276129 , be, and the same is hereby determined to be surplus and is hereby authorized to be sold by negotiation for TWENTY-NINE THOUSAND DOLLARS (\$29,000) to MBM WEST I.
- That the City Manager and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, which is on file in the office of the City Clerk as Document No. RR-276129quitclaiming to MBM WEST I, those certain easements, as more particularly described in said quitclaim deed.
- That no broker's commission shall be paid by City on the herein described negotiated sale.
- That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
