BE IT RESOLVED, by the Council of The City of San Diego that the low bid of GOLDKAMP LANDSCAPING, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing COMPLETE LANDSCAPE MAINTENANCE OF DESIGNATED CENTER MEDIANS, RIGHTS-OF-WAY AND OPEN SPACE WITHIN THE PENASQUITOS EAST LANDSCAPE MAINTENANCE DISTRICT as may be required for a period of one (1) year beginning September 1, 1990 through August 31, 1991, per prices on file in the Purchasing Department, for a total estimated annual cost of \$59,500.00; terms 2% 20 days, with options to renew contract for four (4) additional one (1) year periods with price escalations not to exceed 5% of prices in effect at the end of each prior year.

BE IT FURTHER RESOLVED that in the event the Contractor does not perform to specifications the Purchasing Agent is hereby authorized to terminate the contract and award to the next low responsive and responsible bidder and to subsequent bidders, if necessary, until a bidder is found who performs to specifications.
