BE IT RESOLVED, by the Council of The City of San Diego that the low acceptable bid of VOICE & VIDEO, INC., meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for a sixty (60) month LEASE/PURCHASE OF AUDIO-VISUAL EQUIPMENT as may be required; the purchase price of the equipment to be \$267,079.25, total lease payment to be \$324,613.20, per payment rates on file in the Purchasing Department, payable monthly in advance; lease subject to termination at the end of any fiscal year per terms of bid should funds not be appropriated by the City Council; City to assume title to equipment at end of the sixty (60) month period; with option of upgrading any item of equipment at end of two (2) years at renegotiated prices with adjustments for trade-in value. Failure to reach an agreement acceptable to the Purchasing Agent shall permit termination of that portion of the contract without penalty to the City.
