ADOPTED ON JUL 23 1990

BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for THE IMPROVEMENT OF SKYLINE DRIVE FROM VALENCIA PARKWAY TO DEERROCK PLACE, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on JUL 23 1990, and bearing official Document No. W.D. 118900, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for IMPROVEMENT OF SKYLINE DRIVE FROM VALENCIA PARKWAY TO DEERROCK PLACE.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$30,000 from Deposit Trust Funds No. 63021, to CIP Trust Fund No. 63022.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$30,000 from CIP Trust Fund No. 63022, SKYLINE DRIVE FROM VALENCIA PARKWAY TO DEERROCK PLACE Fund No. 52-377.0.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$1,077,518 from CIP No. 52-377.0, SKYLINE DRIVE - VALENCIA PARKWAY TO DEERROCK PLACE (\$59,118.00 from Gas Tax Fund No. 30219, \$988,400 from Prop. "A" Fund No. 30300 and \$30,000 from CIP Trust Fund No. 63022), is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
