RESOLUTION NUMBER R- 276184

ADOPTED ON III 23 1990

WHEREAS, The City of San Diego ("City") and Northern Automotive ("Northern") entered into a donation agreement whereby Northern donated and transferred title to certain murals and other artwork and artifacts (together being the "Artwork") to the City with the Artwork being described more thoroughly in Attachment A of Resolution No. R-275256, dated March 12, 1990, in which City accepted the donation and transfer of title; and

WHEREAS, City and Luis E. Garcia, Inc. ("LEG, INC.") entered into a loan for use agreement regarding the display of the Artwork pursuant to City Council Resolution No. R-275257 of March 12, 1990; and

WHEREAS, the Council of The City of San Diego expressed its desire that the Artwork be accessible to the general public and remain located in the Barrio Logan community, and to that end, perhaps be located in the Cultural Center of the Mercado del Barrio Project, a proposed redevelopment project under the California Redevelopment Law, Health and Safety Code section 33000 et seq.; and

WHEREAS, LEG, INC., a general contracting firm located in the Barrio Logan community, will display and care for the Artwork at Chuey's Restaurant, 1160 Crosby Street, in the Barrio Logan community until such time as a permanent display area can be found and/or built; and

WHEREAS, Northern shall deliver the Artwork to City sixty (60) days after the issuance of a demolition permit for the Aztec Brewery located at 2301 Main Street in San Diego; and


WHEREAS, the San Diego Community Foundation has donated five thousand dollars (\$5,000) to the City on behalf of the Ingrid and Joseph Hibben Fund and the Beth V. Paynter Memorial Fund ("Benefactors") for display of the Artwork; NOW, THEREFORE

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby accepts the five thousand dollar (\$5,000) donation from the San Diego Community Foundation and the City Manager be and is hereby authorized to expedite the expenditure of these funds and contract for the specialized services associated with relocation, storage and installation of the Artwork.

BE IT FURTHER RESOLVED, by the City Council that the San Diego Community Foundation and the Benefactors are commended for their civic generosity in the support of public art.
