WHEREAS, the City Council on June 11, 1990, authorized the City Manager to enter into 36 social service contracts, and provided one month funding rather than the normal 12 months funding due to pending financial constraints facing the City in Fiscal Year 91; and

WHEREAS, the City Council, sitting as the Committee of the Whole, has set aside sufficient funds to extend such contracts for 12 months at the current funding level; and

WHEREAS, this action would extend the current contractors' funding to 12 months, which represents the same funding levels as received in prior agreements of Fiscal Year 1990; and

WHEREAS, in order to offset a project deficit of approximately \$38,000 for the Fiscal Year 1991 Senior Nutrition Program due to increases in food and handling costs, it is necessary to increase the fee charged to seniors by \$0.25, from \$1.25 per meal to \$1.50 per meal; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to increase the fee per meal for participants in the Senior Nutrition Program, operated by the San Diego Unified School District by \$0.25.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$1,920,814 from the General Fund (Fund No. 100) to the Human Care Services Special Fund (Fund No. 19663).

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$3,307,333 (\$1,964,719 from Human Care Services Special Fund (Fund No. 19663); \$1,342,614 from Fund No. 18526 (16th Year CDBG Entitlement)), is hereby authorized, solely and exclusively for the operation of 36 social service programs.
