BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$99,960.00 from Sewer Revenue Fund 41506, CIP No. 46-106, from the annual allocation, Sewer Pump Station Restorations, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
