For the purpose of executing this agreement, \$487,390.00 is contingent upon Council approval at the FY 1991 Utilities Capital Improvement Budget.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances warrant.
