
ADOPTED ON JUL 24 1990

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of those public rights-of-way for pedestrians and non-motor-vehicle deed of JMB/Santa Fe Venture, a California general partnership, bearing date of March 2, 1990, executed in favor of The City of San Diego, a copy of said deed is on file in the office of the City Clerk as Document No. RR- 276204 , granting to said City a right-of-way for public walkway and non-motor-vehicular purposes in that vacated portion of California Street between "F" Street and "G" Street, as more particularly described in said deed and shown on Drawing No. 17582-B, be and the same is hereby approved, and the land therein conveyed is hereby dedicated as and for a pedestrian and non-motor-vehicle right-of-way.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
