

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Fund Transfer Agreement with the METROPOLITAN TRANSIT DEVELOPMENT BOARD, to provide a study of the feasibility of a Mira Mesa Light Rail Transit (LRT) Extension to the North University City Spur, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 276229.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$250,000 from Facilities Benefit Assessment Fund 79006, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
