

RESOLUTION NUMBER R- 276246
ADOPTED ON JUL 30 1990

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
SAN DIEGO, CALIFORNIA DETERMINING THAT THE
PUBLIC INTEREST AND NECESSITY DEMAND THE
ACQUISITION AND CONSTRUCTION OR COMPLETION OF
A NEW CENTRAL LIBRARY AND OTHER LIBRARY
FACILITIES AND MAKING CERTAIN OTHER FINDINGS
AND DETERMINATIONS IN CONNECTION THEREWITH.

WHEREAS, this City Council is in receipt of a report of the
City Manager setting forth in detail the needs of the City for
the acquisition of a new Central Library and other library
facilities of the City (hereinafter "Facilities"); and

WHEREAS, said report contains an estimate of the cost of
such Facilities, which estimate is one hundred forty-five million
dollars (\$ 145,000,000.00); and

WHEREAS, said cost exceeds the funds available to the City
to acquire such Facilities; and

WHEREAS, said report of the City Manager recommends that a
measure for incurring indebtedness through the issuance of
general obligation bonds of the City be submitted to the voters
of the City, at an election to be called and held on November 6,
1990;

NOW THEREFORE; the City Council of The City of San Diego,
California, DOES HEREBY FIND, RESOLVE, DETERMINE AND ORDER as
follows:

Section 1. That the recitals set forth hereinabove are true
and correct in all respects.

Section 2. That pursuant to Section 43607 of the Government Code of California, it is hereby found that public interest and necessity demand the acquisition and construction of municipal improvements consisting of the Facilities and for the payment of all costs and expenses in connection with such acquisition and construction and the issuance of such bonds.

Section 3. That the public interest and necessity require that a measure be submitted to the voters on November 6, 1990, for the incurring of bonded indebtedness of the City in the amount of one hundred forty-five million dollars (\$145,000,000.00) for the purpose of providing funds for such Facilities, and for the payment of such costs and expenses.

Section 4. Any resolution of the City and any part of such resolution inconsistent with this resolution is hereby repealed to the extent of such inconsistency.
