

Basis for Transfer: In accordance with current negotiation procedures, all base revenue and annual tax increment (ATI) presently allocated to the detaching agencies is to be transferred to the annexing agency, except that when the annexing agency is a city such as Santee which is in the County library system, a portion of the ATI being transferred shall be allocated to the County library.

Comment: If this reorganization is modified by LAFCO to include the CSA69 (Heartland Paramedics), the same property tax distribution shall apply.
