That SEDC's President, or his designee, is hereby authorized to make budgetary transfers between the budgeted line items in accordance with Section 1.06 of the Operating Agreement between the Agency and SEDC which is on file in the Office of the City Clerk as Document No. RR- $\frac{276270}{2}$
