RESOLUTION NUMBER R- 276278

ADOPTED ON AUG 06 1990

BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. SPECIALTY LIGHTING DISTRIBUTORS, 2. HYDE ELECTRICAL SUPPLY, 3. SPECIALTY LIGHTING DISTRIBUTORS, and 4. R & R INTERNATIONAL EXPORTS, meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for furnishing LAMPS as may be required for a period of one (1) year beginning August 1, 1990 through July 31, 1991, per prices on file in the Purchasing Department, with options to renew contracts for four (4) additional one (1) year periods as follows:

1. SPECIALTY LIGHTING DISTRIBUTORS for Sections I and II, Large Lamps, terms 3% 21 days, plus sales tax, with option year increases not to exceed 3.5% of prices in effect in each prior period.
2. HYDE ELECTRICAL SUPPLY for Sections III, IV, V, and VI, Photo, Stage, & Studio Lamps, terms 2% 25 days, plus sales tax, with option year increases not to exceed 10% of prices in effect in each prior period.

3. SPECIALTY LIGHTING DISTRIBUTORS for Section VII, Low Pressure Sodium Lamps, terms 3% 21 days, plus sales tax, with option year increases not to exceed 3.5% of prices in effect in each prior period.
  
4. R & R INTERNATIONAL EXPORTS for Section VIII, Exclusive Brand Lamps, terms net, plus sales tax, with option year increases not to exceed 14% of prices in effect in each prior period.
