BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for MID-CITY COMMERCIAL REVITALIZATION PROGRAM PHASE 4 CITY HEIGHTS WEST UNIVERSITY AVENUE (WILSON AVENUE - 37TH STREET), San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on AUG 06 1990, and bearing official Document No. W.O. 119562, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for MID-CITY COMMERCIAL REVITALIZATION PROGRAM PHASE 4 CITY HEIGHTS WEST UNIVERSITY AVENUE (WILSON AVENUE - 37TH STREET).

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$269,250 (\$112,128 from CBDG Fund No. 18520, \$35,000 from CBDG Fund No. 18524, \$119,622 from CBDG Fund No. 18525, and \$2,500 from Capital Outlay Fund No. 30245 (CIP No. 58-007)), is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
